WHEREAS, the Thérèse C. Pfrimmer International Association of Deep Muscle Therapists, Inc., [ADDRESS] ("the Association") owns certain service marks, Registration Nos. 1,548,688 and 1,592,456, and a collective membership mark, Registration No. 1,544,017;

WHEREAS, the uses of the marks are limited to the uses as set forth in the Certificate of Registrations of the marks, which for the service marks, Registration Nos. 1,548,688 and 1,592,456 is for "Association services, namely, promoting the interests of certified muscle therapists," and for the collective mark, Registration No. 1,544,017, is for "Indicating membership in an organization which promotes the practice and exchange of information relating to deep muscle therapy;"




WHEREAS, the enumerated uses by the Association of its marks and the Users of their marks will not conflict and infringe each other and result in confusion in the market place.



- 3) The Association agrees to limit any uses of its marks within the areas as set forth above regarding the Association's marks;
- 4) The Users agree to limit any uses of their marks within the areas as set forth above regarding the Users' marks;
- 5) The parties agree to take any further actions and execute any further agreements necessary to carry out the spirit and intent of this agreement;
- 6) The parties agree to avoid any activity hereafter which might lead to a likelihood of confusion between their respective marks.
- 7) This agreement shall be construed according to the laws of the Commonwealth of Pennsylvania.


